## Purpose

The Landfill Operators Certification Training Program is designed to provide certification for Class I Landfill Operators in accordance with TCA 68-211-853. You will gain invaluable information concerning the basic skills and regulations required to operate a landfill.

## Who Should Attend

All landfill owners and operators are encouraged to attend this "state certification" program. Any other interested parties involved in landfill operations are welcome as well, including Class II, III and IV landfill operators.

## Date, Time & Location

The Landfill Operators Certification Training Program will be held at the Montgomery Bell State Park in Burns, April 2-5, 2012. This four-day course will begin promptly at 10 a.m. CDT on Monday, April 2<sup>nd</sup>, and will conclude at noon, Thursday, April 5<sup>th</sup>. Applicants needing certification must take the test on Thursday.

**NOTE: Bring hard-soled boots/shoes and appropriate clothing for landfill visit and surveying exercise.**

The cost for the training course is \$400 per person. This cost includes tuition, course materials and the certification examination. Lunch will be provided on all the training days, but not on the day of the test. There will be two outdoor exercises. Be sure to bring appropriate attire for these exercises.

From I-40 East from Memphis or I-40 West from Nashville: Take I-40 to Exit 182 (Fairview/Dickson Hwy. 96 Exit). Turn right (West) onto Highway 96. Stay on Highway 96 until it dead-ends at Highway 70. Turn right (East) on Highway 70, off-ramp provided. Stay on Highway 70 approximately 3 miles. Park entrance is on the right.
