

THE TENNESSEE COMMISSION ON FIRE FIGHTING PERSONNEL STANDARDS AND EDUCATION

June 11, 2013 Business Meeting 500 James Roberson Parkway, Nashville TN.

Approval on Meeting Minutes:

Commissioner Sorge makes a motion to postpone reading the meeting minutes from last meeting on May 22, 2013, except for those pertaining to hiring the New Director. Seconded by Commissioner McCormick.

Guests

Jeff Elliott, Tennessee Fire and Codes Academy (TFACA) Program Director gave a report on the academy programs. Recruit class, July 3rd will be when the recruits will be in their live burn week. A transition to July 13th and 14th in conjunction with the Tennessee Fire Chief's Convention here at the Airport Marriott, there is going to be a NFA direct delivery of the White

Helmets and Politics. September 9th is the next recruit class. The Tennessee Virginia weekend, The classes are going to be Methods of Enhancing Safety Education, NIMs Incident Command System Train the Trainer, Incident Safety Officer, Incident Command System for Structural Collapse, Introduction to Unified Command for Multi Agency and Catastrophic Incidents, Preparations for initial company operations, and Shaping the Future, so those are the seven (7) classes that are being offered.

The class for the Tennessee Fire Chief's orientation is free; the next scheduled class is in Milan, it is June 22nd and 23rd. The Politics and White Helmets class is a grant class and is also free. The last scheduled class is in November at the academy.

Communications

Attorney Dan Birdwell is giving a report on the Firefighting Commission Field Representatives contracts and the extensions to August 30th. There are three (3) RFP, East, Middle and West Tennessee, two (2) field representatives for each region and we have prepared and amendment and sent it to existing field representatives to extend their contracts through August and increased the maximum amount those contracts had.

Commissioner West reports that there was a meeting with HR along with others and put together the job description and duties for the full time positions. They will be full time state employee positions.

Director's Report

Commissioner Gary West gave the Director's report; all of the tests that were in the office have been graded with no back logs now, letters are going out immediately and certificates are going out within two (2) weeks. Our process has really improved because of we are taking applications and requests by e-mail now. The field reps have been working hard and they are working well with our staff. The Commission asked at the last meeting that I provide Fire Departments that are participating in the commission program. Copies of the Fire Departments that participate in the Fire Commission program and also copies of the names of the Fire Departments who do not participate were provided. In the last four (4) to six (6) weeks we have brought on five (5) Fire Departments. This will help with the recruitment efforts.

Old Business

Chairman, Mark Finucane presents the discussion on Jones and Bartlett proposal for approval of their training materials if you recall back in the meeting in December 2012 at Franklin.

Commissioner Wakefield makes a motion to approve the training curriculums by Jones and Bartlett. Seconded by, Commissioner Cotton.

A request from the Dean at Jackson State Community College for approval of their courses to start fire science curriculum courses at the college.

Commissioner West is asking for approval of Firefighter training programs for the 2013 training year. Some departments have received the letters approving their training program prior March 1, 2013. The ones in front of you are the ones that still need to be approved. There is only one fire department that has not submitted the in-service training information and that is Sparta.

Motion on the floor by Commissioner Wakefield to approve the in-service training programs and seconded by Commissioner Slay.

Consideration for a waiver from the Memphis Fire Department for submittal for

supplemental pay past the March 1, 2013 submittal deadline. Commissioner West states that in front of you are the requests for supplemental pay. The Memphis Fire Department is the biggest Fire Department in Tennessee and they are the biggest participant of the supplemental pay program, with 1,480 people requested this year. It is quite a challenge to work with all these people and meet the standards within the supplemental program. From an administrative standpoint, in the past, verification sheets came in overtime even into July and August.

Chief Boyd states that at one time there could be 30 to 40 people off sick, just January and February there are 30 people off because of injuries and five (5) overseas deployed, so at times it is difficult getting signatures. I have been off six weeks for surgery and Lieutenant Bryant was having some family issues as well.

Chairman Finucane wants to discuss a rule change at the next meeting.

Motion on the floor by Commissioner Vance to approve the waiver from the Memphis Fire Department for the submittal of the supplemental pay past the March 1, 2013 deadline, seconded by Commissioner Sorge.

For consideration, a recommendation of the Firefighting Commission Committee to hire a director. The committee to hire the new director met on May 2, 2013 in Gatlinburg. Members of that committee were Commissioner Biggs, Commissioner Slay, Commissioner Naifeh, Commissioner McCormick, Commissioner Majchrzak and Chairman Finucane. There were ten (10) individuals that submitted applications. We came up with four (4) finalists that we were interviewed on May 22, 2013 and May 23, 2013. We had three (3) candidates show up on these dates, one candidate had cancelled. The other three (3) candidates have a broad range of fire service background, both academic and fire service related. It is our recommendation of the three (3) finalists that we would bring forward the name of Randy Fox, as the new Director from the hiring committee.

Commissioner Vance makes a motion to accept the hiring committee's recommendation for Randy Fox for the Director's position, seconded by Chairman Finucane.
