Pre-Admission Evaluations and Referrals for Long-Term Services and Supports (PERLSS) is a modern, cloud-hosted solution that will fully replace and expand the functionality of the TennCare Pre-Admission Evaluation System (TPAES).

This new system will streamline and automate managing programs and workload, increase transparency among partner agencies, centralize the pre-admission evaluation process and more! The implementation will happen in three phases. Stay tuned for more information!
