

# Public Forum on Progress of the TennCare Demonstration

*Published May 31, 2022*

The Commissioner of the Tennessee Department of Finance and Administration is providing official notification, pursuant to 42 CFR § 431.420(c) and the Special Terms and Conditions of the TennCare Demonstration, that a public forum is being held to accept comments on the progress of the TennCare Demonstration.

## **The TennCare Demonstration**

TennCare is a comprehensive Medicaid reform project, consisting of innovations in multiple aspects of the Medicaid program, including eligibility, benefits, and service delivery systems. The primary goals of the TennCare Demonstration include providing high-quality care to members, improving health outcomes for members, and providing members with access to safe and appropriate home and community-based services (HCBS).

To advance these goals, the TennCare Demonstration authorizes several programmatic flexibilities, including—

- Extending eligibility to certain groups that would not be eligible for Medicaid under the State Plan;
- Covering a more robust package of benefits than that authorized under the Medicaid State Plan;
- Use of a single, statewide managed care service delivery system;
- Operating the CHOICES program to provide targeted HCBS and other LTSS to persons who are elderly or who have physical disabilities;
- Operating the Employment and Community First CHOICES program to provide targeted HCBS to individuals who have intellectual or other developmental disabilities;
- Operating a Katie Beckett program for children with disabilities or other complex medical needs;
- Providing financial support to hospitals and safety net providers who furnish care to Medicaid and uninsured populations; and
- Various operational efficiencies.

In addition, the TennCare Demonstration authorizes the State to claim federal matching dollars for Designated State Investment Programs (subject to certain conditions), the use of



a closed formulary, and the temporary suspension of TennCare members convicted of TennCare fraud.

Through the TennCare Demonstration, Tennessee demonstrates that the careful use of a single, statewide service delivery system can enable delivery of high-quality care to all members without spending more than would have been spent had Tennessee maintained a traditional Medicaid program.

A variety of resources are available online to provide information about the TennCare Demonstration. Key concepts and principles related to the demonstration project are outlined in the [agreement](#) between TennCare and the Centers for Medicare and Medicaid Services (CMS) defining the terms and conditions under which the demonstration may operate. ### **TennCare Public Forum**

Each year, TennCare holds a public forum to accept comments from members of the public on the progress of the TennCare Demonstration.

TennCare's next public forum will be held on June 30, 2022, at 2:00 p.m. Central Time.

The following options are available for persons who wish to comment on the progress of the TennCare Demonstration.

***In-Person.*** TennCare's public forum will take place in Room 1 East A on the ground floor of the TennCare building, 310 Great Circle Road in Nashville. Individuals planning to attend in person are encouraged to arrive a few minutes before the event start time in order to be checked in at the front desk.
